#### Notice to the Public Regarding Title VI of the Civil Rights Act of 1964

WCOG hereby gives public notice that it is the policy of the agency to assure full compliance with Title VI of the Civil Rights Act of 1964, the Civil Rights Restoration Act of 1987, Executive Order 12898 on Environmental Justice, Executive Order 13166 on Limited English Proficiency, and related statutes and regulations in all programs and activities. Title VI requires that no person in the United States of America shall, on the grounds of race, color, sex, or national origin, be excluded from the participation in, be denied the benefits of, or be otherwise subjected to discrimination under any program or activity for which WCOG receives federal financial assistance.

Any person who believes they have been aggrieved by an unlawful discriminatory practice under Title VI has a right to file a formal complaint with WCOG. Any such complaint must be in writing and filed with the WCOG Title VI Coordinator within one-hundred eighty (180) days following the date of the alleged discriminatory occurrence. Title VI Discrimination Complaint Forms may be obtained from the WCOG at no cost and are available on WCOG's website.

#### Aviso al Público Sobre Título VI de la Ley de Derechos Civiles de 1964

Por medio de la presente, el WCOG notifica de manera pública que la política del organismo es garantizar el pleno cumplimiento del Título VI de la Ley de Derechos Civiles de 1964, la Ley de Recuperación de Derechos Civiles de 1987, el Decreto Presidencial 12898 sobre Justicia Ambiental, el Decreto Presidencial 13166 sobre Dominio Limitado del Idioma Inglés, así como los estatutos y reglamentos relacionados en todos los programas y actividades. De acuerdo con lo estipulado en el Título VI, ningún individuo de los Estados Unidos de América deberá, con fundamento en su raza, color, sexo o nacionalidad, ser excluido de participar en, que se le nieguen los beneficios de, o ser víctima de discriminación en virtud de calquier programa o actividad por el cual el WCOG reciba fondos federales.

Toda persona que se considere agraviada por una práctica discriminatoria e ilícita en virtud del Título VI tiene derecho a presentar una denuncia formal ante el WCOG. Cualquier denuncia de este tipo debe presentarse por escrito ante el coordinador del Título VI del WCOG en un period de 180 días naturales a partir de la fecha de la presunta discriminación. El WCOG pone a disposición del público los formularios de denuncia del Título VI de manera gratuita en su página web.

4. Additions to the List of Transportation Priorities of Whatcom County, 2020

Mr. Wilson informed the Board that the "30 percent design" study WCOG commissioned for the proposed State Route 547 Pedestrian and Bicycle Safety Trail had been completed by the consultant in December, and that he had received a request from the Kendall-Columbia Valley Connectivity Plan Association – on whose behalf the study had been conducted – to add the first phase of construction of the trail to the list in the amount of \$1.2-million.

**MOTION:** Ms. Vargas moved, Mr. Carter seconded, to add "State Route 547 Pedestrian and Bicycle Safety Trail, Phase 1" to the list of Transportation Priorities of Whatcom County, 2020, in the amount of \$1.2-million.

#### **RESOLUTION NO. 2020-01**

#### AFFIRMING THE WHATCOM COMPLETE COUNT COMMITTEE

WHEREAS, the Whatcom Council of Governments is the designated conference of governments authorized by the Washington State Legislature and established in 1966, serving the local governments, tribes and special districts of Whatcom County, and

WHEREAS, the Government of the United States of America will conduct its decennial Census of Population in April 2020, the results of which will be used to determine the number of seats apportioned to each State in the U.S. House of Representatives, and to establish formulas for the distribution of federal funding to the States, and

WHEREAS, the Whatcom Council of Governments acknowledges the great importance of the Census to Whatcom County and its constituent cities, as well as to the State of Washington and the United States, and

WHEREAS, the Whatcom Council of Governments is committed to ensuring that all residents of Whatcom County are counted, and to that end established by motion the Whatcom Complete Count Committee at its meeting of December 11, 2019.

**NOW, THEREFORE, BY THIS RESOLUTION** the Whatcom Council of Governments affirms its establishment of the Whatcom Complete Count Committee and pledges its full cooperation and assistance to ensure a complete count of all residents of Whatcom County in the 2020 Census.

Subject: Resolution 2020-02 Electronic Signatures and Records

Staff has prepared attached Resolution 2020-02 to allow the use of electronic signatures and records. RCW 19.360.020 and as amended by SSB 6028 Uniform Electronic Transactions Act specifically allows local government agencies to send and accept electronic submissions and electronic signatures, except as otherwise provided by law. To use electronic submissions and signatures, local government agencies must establish a method and process for electronic submission and use of electronic signatures by ordinance, resolution or policy.

The Act applies only to transactions between parties which have agreed to conduct transactions by electronic means. Whether the parties agree to conduct a transaction by electronic means is determined from the context and surrounding circumstances, including the parties' conduct.

There are numerous WCOG business transactions which require one or more signatures on a regular basis. Examples are grant reporting, certifications, billings, payroll and accounts payable authorizations, meeting minutes of the Council Board and Transportation Policy Board meetings, contracts and other documents. Staff has determined the most secure and verifiable method to obtain electronic signatures for WCOG's business transactions is to use a certificate-based electronic signature system. Staff has been testing Adobe Sign to obtain signatures on internal documents such as staff time and activity reports while working remotely.

#### **RESOLUTION NO. 2020-02**

#### **USE OF ELECTRONIC SIGNATURES AND RECORDS**

WHEREAS, Pursuant to Chapter 19.360.020 RCW and as amended by Substitute Senate Bill 6028 Uniform Electronic Transactions Act, effective June 11, 2020, unless specifically provided otherwise by law or agency rule, whenever the use of a written signature is authorized or required by this code with a state or local agency, an electronic signature may be used with the same force and effect as the use of a signature affixed by hand, as long as the electronic signature conforms to the definition in RCW 19.360.030 and the writing conforms to RCW 19.360.040; and

WHEREAS, Each local agency may determine whether, and to what extent, the agency will send and accept electronic records and electronic signatures to and from other persons and otherwise create, generate, communicate, store, process, use, and rely upon electronic records and electronic signatures. RCW 19.360.020 (2); and

**WHEREAS,** The method and process for electronic submissions and the use of electronic signatures must be established by ordinance, resolution, policy, or rule. RCW 19.360.020 (5)

**NOW, THEREFORE, BY THIS RESOLUTION** the Whatcom Council of Governments does hereby authorize the use of electronic signatures and records for SCOG business transactions. Unless specifically provided by law or agency rule, whenever the use of a written signature is required, an electronic signature may be used with the same force and effect as the use of a written signature affixed by hand.
